I. WHAT'S RIGHT IN WCSD SCHOOLS

Washington Elementary School – Principal Kelly Mitchell

Principal Kelly Mitchell and Learning Coach Kristen Brown shared the success of All Day Kindergarten at Washington Elementary School. This was the first year available for the full day and the school had 100% opt in. The academic data was presented shows student progress and improvement assessments. Washington Elementary is a model school for this with professional learning committees in action. They are changing child's lives.

Snow Canyon High School – Principal Kim Monkres

Principal Kim Monkres shared how their teachers have taken a new approach to reach out and recommend CE Courses, Science, and AP course to students who would otherwise not take the courses. Warrior Student Body held Bigger than Basketball, Wish Week, Fan Fest, and a Road Show which involved the special needs community in these events. The teenagers have good hearts and are learning kindness. It was powerful to enlighten the students and show that they believe in helping those with disabilities be included at the school.

Early Learning Plan – Kathy Hall & Monica Chadaz

Kathy Hall asked for the approval of the Early Learning Plan. She is the Literacy Coordinator for the District and Monica Chadaz is the Math Specialist. Kathy said that they have goals for the first and second grade students to close those gaps to get them where they need to be. The Kindergarten is doing an amazing job, so they would like to focus on the first and second grades. Three test at the end of the year are given for the computation score. The plan is to provide professional learning training for the teachers to help support them and build foundational understanding to be able to share with students. As an action item they asked for the approval of the Early Learning Plan which has been provide to the Board.

Board Member Cox asked about the Letters training which is a two year Professional Development program. It provides language essentials for teachers of spelling and reading. The teachers are given book reading assignments, online work at home with modules, bridge to practice, face to face with a letter facilitator. Teachers using this is making a difference and scores are improving. Superintendent Bergeson expressed his appreciation for the program and said that math scores are great. He thanked all those involved in this great work.

Board Member Stirland presented a motion to approve the Early Learning Plan. Board Member Hesson seconded the motion that passed unanimously.

DISCUSSION ITEMS**Policy 1400 Drug Free Workplace – Lyle Cox**

Lyle Cox explained that gives some protections for legal use of cannabis treated as a prescription or medication. The policy adds protection that no one should show up for work being impaired even with a legal or illegal substance.

Policy 3620 Campus Management – Lyle Cox

Lyle Cox explained the campus management for monitoring school grounds. Training for the cross walk and playground aids requires Motor Vehicle Act requires supervision management and training provided by the local highway authority which is the city or state. Requires supervisor training and background check to make it legally compliant.

Policy 0002 Board Meetings – Lyle Cox

Lyle Cox explained that vulgar or included obscene language to maintain decorum in the meeting.
